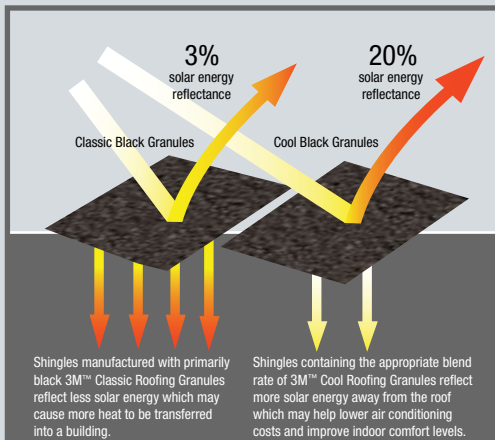
Protecting the environment is a crucial business issue that Malarkey Roofing Products has taken seriously since 1984. In partnership with

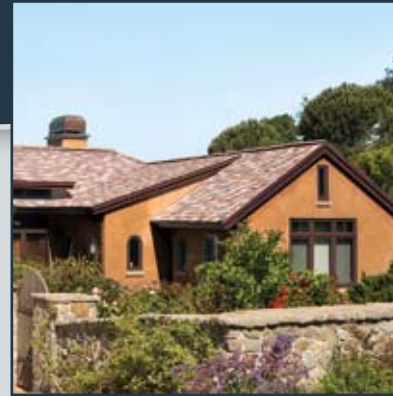
